

Agreement between
International Scouting Collectors Association (ISCA)
and
Brian & Garry Ives (Ives)

**To provide for a Relationship for the use of an online Website for a Boy Scouts
of America Trade-o-ree Calendar including Management of an ISCA Store Functionality**

MUTUAL AGREEMENT

I. PURPOSE:

Both ISCA and Ives desire to have a robust trade-o-ree website to provide information about trade-o-ree events to the hobby of Scouting Memorabilia Collectors.

II. BACKGROUND:

- 1) ISCA has in the past maintained a trade-o-ree listing on it's website (ScoutTrader.org) and quarterly would publish this list in the quarterly ISCA Journal. The listing was maintained as an "Opt-in" listing and as such was typically only a small representation of the trade-o-rees across the country.
- 2) Ives presently has a more robust website and has been working on adding additional features to the existing bsator.com trade-o-ree website at Ives expense. Part of the success of the Ives website can be attributed to the proactive approach taken to solicit information from trade-o-ree organizers and to obtain trade-o-ree information and fliers from other sources. This has created a website with many more trade-o-rees being listed.

KEY POINTS OF THE AGREEMENT:

III. Ives RESPONSIBILITIES:

- 1) Ives will provide for and maintain the bsator.com website at it's own expense.
- 2) Ives will provide a banner with the ISCA logo/nomenclature (and link to the ISCA website) at or near the top of the opening home page similar in size to the ScoutingsBest.com heading and/or bsator heading.
- 3) Ives will also provide additional links and information about ISCA as deemed appropriate and agreed upon by ISCA and Ives (i.e.: in the black header near the top of the page) and will also include information about this relationship (as described in this contract) on the bsator.com website.
- 4) Other headers such as ScoutingsBest.com and ShoppingBin.com may also be maintained at Ives discretion.
- 5) Any revenue generated directly by the bsator.com website will belong to Ives.
- 6) Ives will provide the ability for ISCA to list items for sale utilizing the website, i.e.: an ISCA Store listing.
- 7) Ives will also maintain the ISCAStore.com domain using Ives GoDaddy account and will relinquish/transfer it to ISCA in the future at ISCA's request.
- 8) For every ISCA item that sells on the bsator.com site, ISCA will keep 100% of the proceeds and the funds will be deposited directly to an ISCA PayPal Account.

IV. ISCA RESPONSIBILITIES:

- 1) ISCA will provide a link to the bsator.com from the ISCA website.
- 2) ISCA will publicize trade-o-rees and will link to this website from the ISCA website.
- 3) ISCA will give credit to Ives for the use and linking to the bsator.com website.
- 4) ISCA will pay for the ability of listing items for sale as separately agreed upon.
- 5) ISCA will also own the domain name: ISCAStore.com and will keep the domain active and will pay for renewal fees when they become due.

V. INTELLECTUAL PROPERTY (IP):

- 1) It is recognized that Ives owns the bsator.com website and is providing a service to the hobby . . . and that ISCA is leveraging this service by way of providing a direct link from the ISCA website to the bsator.com website for the purpose of furthering its use by the hobby.
- 2) As part of the agreement, any and all information on Bsator.com (such as trade-o-ree listings, calendars, images, etc.) may be published by ISCA in its quarterly publication, the ISCA journal and on it's website to publicize specific events, but not to duplicate the bsator website or it's functionality.

VI. TERMINATION OF AGREEMENT

This agreement shall be in effect immediately upon both parties signing the agreement and shall remain in effect until a 90 day written notice is given by either party to the other to terminate the agreement.
